Experience

Work highlights

PETROBRAS URUGUAY AND AXION ENERGY. Guyer & Regules represents the subsidiary of the Brazilian state oil company Petrobras (PUDSA) and the Argentine multinational Axion Energy in two independent judicial arbitration agreements against the National Administration of Fuels, Alcohols and Portland - ANCAP, a Uruguayan state-owned company with a monopoly on the import and refining of oil.

GNLS S.A. (LOCAL SPV OF INTERNATIONAL COMPANIES ENGIE AND MARUBENI). Guyer & Regules represents GNLS S.A. in an arbitration proceeding initiated by GNLS against Construtora OAS S.A. The Uruguay branch of Construtora OAS S.A. contracted GNLS for the construction of the regasification terminal that involved work on land and at sea. GNLS interprets that there was damage caused in the amount of USD 370 million as there were violations of the contract. Construtora OAS tried to avoid arbitration jurisdiction by initiating legal proceedings in Uruguay.

URUGUAYAN BASF S.A AND BASF SE. Guyer & Regules is currently advising the leading companies BASF Uruguay S.A. and BASF SE in a multi-million dollar lawsuit filed by the former distributor in Uruguay, Solaris Tecnología Agrícola S.A., of its agrochemical products.

CAISA. CAISA, the international airport operator of Punta del Este, was represented by our firm in a lawsuit filed by the Uruguayan state airline PLUNA for breach of a lease of services for the provision of basic services and additional handling to aircraft at the airport. PLUNA alleged that the values agreed in the contract and those invoiced by CAISA to the airlines operating at the airport between 2010 and 2013 were different.
